## Privacy policy for membership

The personal data you provide by filling out the declaration of membership will be processed and used by us in accordance with the EU General Data Protection Regulation (GDPR).

1. Following Article 6(1) of the GDPR, the processing of personal data shall be lawful only if it is necessary to fulfil the legal obligation of the contract – here: membership in the association.
2. Your personal data will be used to initiate and manage your membership in the association.
3. With the termination of membership your data will be stored in accordance with the statutory retention period for 10 years and then erased. Between the termination of your membership and the deletion, the processing of your data is limited.
4. Your name and surname will be stored internally in the association archive for chronicle purposes. The storage underlies a legitimate interest to archive the historical composition of the association.
5. With respect to the General Data Protection Regulation (GDPR) you have the following rights:
  1. Right of access (Article 15 GDPR)
  2. Right to rectification (Article 16 GDPR)
  3. Right to erasure ('right to be forgotten') (Article 17 GDPR)
  4. Right to restriction of processing (Article 18 GDPR)
  5. Right to object (Article 21 GDPR)
  6. Right to lodge a complaint with a supervisory authority (Article 77 GDPR)

A request needs to be sent in text form to the privacy officer (see below).

6. To fulfil the contract, the association requires your data. If you object the processing or request the erasure of your data, your membership in the association will terminate at the next possible date, as set by the Articles of the Association.
